

**Summary Annual Report**  
for

This is a summary of the annual report for the Alyeska Pipeline Service Company Retiree Group Medical and Dental Plan for, (Employer Identification No. 92-0039154, Plan No. 519) for the period January 1, 2022 to December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**INSURANCE INFORMATION**

The plan has a contract with LIFEWISE ASSURANCE COMPANY to pay the following types of claims incurred under the terms of the plan.

All Medical, Dental claims

The total premiums paid for the plan year beginning January 1, 2022 and ending December 31, 2022 were \$125,575.

The value of plan assets, after subtracting liabilities of the plan, was \$-48,143 as of December 31, 2022 compare to \$-237,788 as of January 1, 2022. During the plan year the plan experienced an increase in its assets of \$189,645. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$2,996,730. This income included employer contributions of \$2,325,000, employee contributions of \$531,611 and earnings from investments of \$2,365. Plan expenses were \$2,807,085. These expenses included \$106,345 in administrative expenses and \$2,700,740 in benefits paid to participants and beneficiaries.

#### PAPERWORK REDUCTION ACT STATEMENT
