

**Summary Annual Report**  
for

Alyeska Pipeline Service Company  
Medicare Eligible Reimbursement Health Plan

This is a summary of the annual report for the Alyeska Pipeline Service Company Medicare Eligible Reimbursement Health Plan, (Employer Identification No. 92-0039154, Plan No. 520) for the period January 1, 2022 to December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Alyeska Pipeline Service Company has committed itself to pay the following types of claims incurred under the terms of the plan.

All Health claims

The value of plan assets, after subtracting liabilities of the plan, was \$96,879 as of December 31, 2022 compare to \$151,881 as of January 1, 2022. During the plan year the plan experienced a decrease in its net assets of \$55,002. This decrease includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$2,127,518. This income included employer contributions of \$2,125,000 and earnings from investments of \$2,518. Plan expenses were \$2,182,520. These expenses included \$65,918 in administrative expenses and \$2,116,602 in benefits paid to participants and beneficiaries.

#### PAPERWORK REDUCTION ACT STATEMENT
