

**Summary Annual Report**  
for

Alyeska Pipeline Service Company Group Medical and  
Dental Plan for Operating Company Employees

This is a summary of the annual report for the Alyeska Pipeline Service Company Group Medical and Dental Plan for Operating Company Employees, (Employer Identification No. 92-0039154, Plan No. 501) for the period January 1, 2023 to December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**INSURANCE INFORMATION**

The plan has a contract with LIFEWISE ASSURANCE COMPANY to pay the following types of claims incurred under the terms of the plan.

All Medical, Dental, Vision claims.

The total premiums paid for the plan year beginning January 1, 2023 and ending December 31, 2023 were \$686,958.

The value of plan assets, after subtracting liabilities of the plan, was \$-333,478 as of December 31, 2023 compare to \$1,089,021 as of January 1, 2023. During the plan year the plan experienced a decrease in its net assets of \$1,422,499. This decrease includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$17,687,433. This income included employer contributions of \$13,070,930, employee contributions of \$3,772,651 and earnings from investments of \$71,346. Plan expenses were \$19,109,932. These expenses included \$435,111 in administrative expenses and \$18,674,821 in benefits paid to participants and beneficiaries.
